

RESOLUTION #2908

**AWARD CONTRACT FOR PLUMBING REPAIR CONTRACTOR TO
OWEN S. DUNIGAN & CO., INC. FROM 1/1/18-12/31/18**

WHEREAS, the Housing Authority of the Township of Woodbridge, New Jersey (Authority) needs to establish a plumbing repair service contract with a qualified Plumbing Contractor; and

WHEREAS, this contract is to be awarded through a “fair and open process” pursuant to N.J.S.A. 19:44A-20.4 et. seq.; and

WHEREAS, the Authority created proposal documents and specifications dated 12/27/17 for a one year service contract for plumbing repair services; and

WHEREAS, following timely advertisement for proposals in the Home News Tribune on 12/9/17, for same, four proposals were received in the Office of the Executive Director until 2:00 PM on 12/27/17, at which time the proposals were considered in accordance with the selection process defined in the specifications, with evaluation results as follows:

Brightman be, and hereby is authorized and directed to execute and deliver on behalf of the Authority a one-year contract for services as specified in the Request for Proposals for Plumbing Repair Services in the amount of \$90.00 / hr (\$150.00 / hr OT) for a qualified plumbing technician from January 1, 2018 – December 31, 2018 for an amount not to exceed \$40,000.00.
