

RESOLUTION #3095

**AWARD CONTRACT FOR PEST CONTROL SERVICES TO E&G EXTERMINATORS INC.
FROM 11/6/20 THROUGH 11/5/22 FOR \$30,096.00**

WHEREAS, the Housing Authority of the Township of Woodbridge (the “Authority”) needs to establish a service contract with a qualified pest control services contractor; and

WHEREAS, this contract is to be awarded through a “fair and open process” pursuant to N.J.S.A. 19:44A-20.4 et. seq.; and

WHEREAS, the Authority created bid documents and specifications dated April 9, 2020 for a two year service contract for said services; and

WHEREAS, following timely advertisement for proposals in the Home News Tribune on March 18, 2020, for same, the following proposals were received:

WHEREAS, the contract was awarded to Pest-A-Side Exterminating Co., Inc. and subsequently terminated effective November 6, 2020 due to unsatisfactory performance; and

WHEREAS, the second low bidder E&G Exterminators, Inc. having submitted a responsible proposal has agreed to honor the price submitted for pest control service and is hereby recommended for award.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Housing Authority of the Township of Woodbridge, New Jersey, that the Contract for pest control services be awarded to E&G Exterminators, Inc. for the amount of \$30,096.00 for a two year period as per the specifications dated April 9, 2020 starting November 6, 2020 through November 5, 2022.
