

RESOLUTION #3166
AWARD CONTRACT FOR FIRE SUPPRESSION SYSTEM INSPECTION, MAINTENANCE
AND REPAIR SERVICES CONTRACTOR TO
NEWARK FIRE SPRINKLER CORP FROM 12/16/21-12/15/23

WHEREAS, the Housing Authority of the Township of Woodbridge, New Jersey (Authority) wishes to establish a service contract with a qualified Fire Suppression System Repair Contractor; and

WHEREAS, this contract is to be awarded through a “fair and open process” pursuant to N.J.S.A. 19:44A-20.4 et. seq.; and

WHEREAS, the Authority created proposal documents and specifications dated November 16, 2021; and

WHEREAS, following timely advertisement for bids in the Home News Tribune on October 15, 2021, for same, the following proposals were opened and read before the public:

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Housing Authority of the Township of Woodbridge (the “Authority”) that the Contract Officer of the Authority, Donna F. Brightman be, and hereby is authorized and directed to execute and deliver on behalf of the Authority a two-year service contract as specified in the request for proposals for Fire Suppression Repair Services in the amount of \$3,725.00 annually from December 16, 2021 – December 15, 2023.
