

RESOLUTION #3232

**AWARD CONTRACT FOR PEST CONTROL SERVICES TO ANCHOR PEST CONTROL
FROM 2/1/23 THROUGH 1/31/24 FOR \$34,860**

WHEREAS, the Housing Authority of the Township of Woodbridge (the “Authority”) needs to establish a service contract with a qualified pest control services contractor; and

WHEREAS, this contract is to be awarded through a “fair and open process” pursuant to N.J.S.A. 19:44A-20.4 et. seq.; and

WHEREAS, the Authority created bid documents and specifications dated December 27, 2022 for a one-year service contract for said services; and

WHEREAS, following timely advertisement for proposals in the Home News Tribune on December 10, 2022, for same, the following proposals were received:

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Housing Authority of the Township of Woodbridge, New Jersey, that the Contract for pest control services be awarded to Anchor Pest Control Services, Inc. for the amount of \$34,860.00 for a one-year period as per the specifications dated December 27, 2022 starting February 1, 2023 through January 31, 2024.
