

## RESOLUTION #3258

### SUBSCRIBING TO A SOLAR LANDSCAPE COMMUNITY SOLAR PROJECT

**WHEREAS**, for more than a decade, the State of New Jersey has promoted energy policies that have created a vibrant solar energy market; and

**WHEREAS**, the State of New Jersey adopted the 2019 New Jersey Energy Master Plan, Pathway to 2050; and the legislature passed the Clean Energy Act of 2018; and

**WHEREAS**, Strategy 6 of the 2019 Energy Master Plan calls for the State to:

Support community energy planning and action with an emphasis on encouraging and supporting participation by low-and-moderate-income and environmental justice communities; and

**WHEREAS**, Goal 6.2.1 of the 2019 Energy Master Plan calls for the support of community-led development of community solar projects; and

**WHEREAS**, the Woodbridge Housing Authority recognizes the benefits of the Board of Public Utility's community solar program for their residents including the following:

- Reduction of energy bills

- Local, clean power generation

- Support for active participation in the program by low-and-moderate-income families

- Job training, certification support, and job placement in the solar industry

**WHEREAS**, the State of New Jersey Board of Public Utilities solicited proposals from solar providers and awarded Solar Landscape, 601 Bangs Ave., Suite 3, Asbury Park, NJ 07712, the contract for our area.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the Board of Commissioners of the Housing Authority of the Township of Woodbridge ("Board") will subscribe to a Solar Landscape community solar project located in Perth Amboy and have the following financial benefit:

- 25% discount on the electricity from the community solar project for Cooper Towers and Olsen Towers master meters paid by the Woodbridge Housing Authority

**BE IT FURTHER RESOLVED** that the Board of Commissioners will execute a Community Solar Subscription Agreement with developer Solar Landscape and utilize financial savings for capital improvements to tenant-occupied facilities; and

**BE IT FURTHER RESOLVED** that the Woodbridge Housing Authority will help make subscriber information available to residents with individual meters for local community solar projects that meet the criteria for our residents' participation.
